15 January 2021	<b>DEADLINE for Registration</b> (Online Form) for all Teams  <b>DEADLINE for Submission of Team Roster:</b> This is the last day on which teams may submit the names of their team members and advisors.
18 January 2021	<b>ANTICIPATED RELEASE of the ILC Cup Problems for the Elimination Rounds.</b> Each team shall be paired off and assigned a Problem.
14 February 2021	<b>ASSIGNMENT of Applicant/Respondent Memorial Sides</b> for Each Pair
15 February 2021	<b>DEADLINE for Submission of Elimination Memorials:</b> Memorials must be submitted to the Organizing Committee in accordance with the Official Rules.
12 March 2021	<b>OPENING CEREMONY of ILC Cup 2021</b> (to be held online). The final schedule for the Elimination Rounds will also be announced at this time, and the exchange of memorials will be done.
15 - 19 March 2021	<b>ELIMINATION ROUNDS:</b> Each Team will compete once as Applicant or Respondent, as the case may be.
24 March 2021	<b>ELIMINATION ROUNDS WINNERS ANNOUNCEMENT</b> (via the ILC Website and social media pages): The winning four teams of the Elimination Rounds will be announced.  <b>ANTICIPATED RELEASE of the ILC Cup Problems for the Semifinals.</b> Each qualifying team shall be paired off and assigned a Problem.
31 March 2021	<b>DEADLINE for Top 2 Qualifiers to Submit Applicant/Respondent Side of Choice for Memorials</b>

<b>12 April 2021</b>	<b>DEADLINE for Submission of Semifinal Memorials:</b> Memorials must be submitted to the Organizing Committee in accordance with the Official Rules.
<b>09 May 2021</b>	<b>ANNOUNCEMENT of the Schedule for the Semifinals.</b> The exchange of Memorials will also be done at this time.
<b>10 - 11 May 2021</b>	<b>SEMIFINALS:</b> Each qualifying team will compete once as Applicant or Respondent, as the case may be.
<b>17 May 2021</b>	<b>SEMIFINAL WINNERS ANNOUNCEMENT</b> (via the ILC Website and social media pages): The 2 Teams that, based on their performance in the Semifinals, will advance to the Final Rounds.  <b>ANTICIPATED RELEASE of the ILC Cup Problems for the Finals</b>
<b>06 June 2021</b>	<b>ASSIGNMENT of Applicant/Respondent Memorial Sides</b>
<b>07 June 2021</b>	<b>DEADLINE for Submission of Final Memorials:</b> Memorials must be submitted to the Organizing Committee in accordance with the Official Rules.
<b>04 July 2021</b>	<b>ANNOUNCEMENT of the Schedule for the Finals.</b> The exchange of Memorials will also be done at this time.
<b>05 July 2021</b>	<b>ILC CUP 2021 FINALS/CHAMPIONSHIP MATCH:</b> The remaining 2 teams will compete for the last time as Applicant or Respondent, as the case may be.  <b>ILC CUP 2021 CLOSING CEREMONY AND PRESENTATION OF AWARDS</b>
